4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Eye contact: If in eyes, hold eyelids apart and flush the eyes continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a Doctor; or for at least 15 minutes and transport to a Doctor or Hospital.

Ingestion: Immediately rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek immediate medical advice.

5. FIRE-FIGHTING MEASURES

SMALL SPILLS

7. HANDLING AND STORAGE

If the directions for use on the product label are followed, exposure of individuals using the product should not exceed the above standard. The standard was created for workers who are routinely, potentially exposed during product manufacture.

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

Acute Effects

Inhalation: Not applicable when stored and handled as directed. The product is a solid rod, however, if it has been crushed the resulting dust may be irritating to mucous membranes and respiratory tract.

Skin contact: Due to the products structure, short-term exposure is unlikely to cause irritation. Repeated or prolonged skin contact will lead to irritation.

Eye contact: Exposure to dust will cause eye irritation, however this is unlikely if the product is stored and handled as directed.

Ingestion: Harmful if swallowed. Swallowing can result in nausea, vomiting and irritation of the gastrointestinal tract.

Long Term Effects: No information available for product.

Ecotoxicity: Mono Ethylene Glycol has moderate short and long term toxicity to aquatic life.

Persistence and degradability: In soil, Mono Ethylene Glycol is expected to degrade in several days to a week into hydroxyacetaldehyde.

Mobility: As all components are water soluble, it's expected to be highly mobile. It's not expected to volatilise in the environment.
