### 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**Skin contact:** If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

**Eye contact:** If in eyes, hold eyelids apart and flush the eyes continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a Doctor; or for at least 15 minutes and transport to a Doctor or Hospital.

### Acute Effects

**Inhalation:** Not applicable when stored and handled as directed. The product is a solid rod, however, if it has been crushed the resulting dust may be irritating to mucous membranes and respiratory tract.

**Skin contact:** Due to the products structure, short-term exposure is unlikely to cause irritation. Repeated or prolonged skin contact will lead to irritation.

**Eye contact:** Exposure to dust will cause eye irritation, however this is unlikely if the product is stored and handled as directed.

**Ingestion:** Harmful if swallowed. Swallowing can result in nausea, vomiting and irritation of the gastrointestinal tract.
